#### Abstract

Marriage compatibility in astrology explores the harmony between partners by analysing planetary influences at their birth. In Western astrology, based on the Sayana (tropical) zodiac, compatibility is viewed through psychological and emotional lenses rather than rigid fate. The Sayana zodiac system aligns the zodiac with the changing seasons, taking the Sun's position at the vernal equinox as the starting point of Aries. Unlike the Nirayana (sidereal) zodiac, which is fixed relative to the constellations, the Sayana system emphasizes the Sun's seasonal position, focusing on symbolic meanings, planetary aspects, and house placements rather than the fixed stars.

Key methods include synastry-comparing two charts to assess inter-aspects between Venus, Mars, Moon, and the 7th house ruler-and the posited planet, which merge two natal charts to reveal the relationship's purpose and dynamics. Modern Western astrology incorporates psychological insight, archetypes, and emotional patterns, focusing on self-awareness, mutual understanding, and free will.

Unlike Vedic astrology's point-based Guna Milan system, the Sayana approach is qualitative. It evaluates communication, emotional resonance, and long-term potential rather than fixed predictions. Relationship challenges are seen as growth opportunities rather than fate-driven problems.

This makes Western astrology particularly valuable in relationship counselling, offering deep insight into shared values, needs, and chemistry. It supports conscious partnership development, highlighting both strengths and areas requiring mutual effort for a lasting and meaningful bond.

While belief in astrology varies, its philosophical and observational roots continue to fascinate both skeptics and believers.

Astrology is based on the principle that planetary positions and movements reflect or influence human behaviour, life patterns, and destiny. It helps explain why people with similar efforts may experience different life outcomes. This cosmic correlation makes astrology a valuable tool for exploring karma, personal growth, and relationships-especially marriage, which holds deep cultural and spiritual importance in India.

Several branches of astrology exist, each with unique applications. These include Tantra, Hora, Muhurta (electional), Tajaka (Persian system), Prashna (horary), Shakuna (omens), Medini Jyotisha (mundane astrology), and Samhita (compilations). Of these, Hora Shastra is particularly central for natal chart analysis and compatibility evaluation.

Astrological practice splits into two primary systems: Nirayana (sidereal), as used in traditional Indian astrology, and Sayana (tropical), used in Western astrology. The Nirayana system relies on a fixed zodiac beginning with a reference star in Aries, while the Sayana system begins from the moving vernal equinox. The gap between the two, known as Ayanamsa, results from the precession of equinoxes. The Nirayana system emphasizes karma and spiritual destiny, while the Sayana approach highlights personality traits, psychological evolution, and inner development. The Western system uses tools like house cusps, aspects, and secondary progressions for dynamic interpretation.

In India, marriage is not just a social contract but a spiritual commitment. Compatibility analysis remains a crucial component of Indian astrology. Northern India often uses the Ashta

Koota (Guna Milan) system, while the South prefers the Dasa Koota method. However, advanced compatibility assessments go beyond point systems, considering the 7th house, Venus, Moon, Mars, Sun, and divisional charts like the Navamsa (D9), as well as afflictions such as Manglik Dosha. Modern methods like KP Astrology add further precision to marital predictions.

Modern Western astrology mainly focuses on directive guidance-helping people understand what actions they should take, rather than only predicting what will happen. It includes the influence of outer planets like Uranus, Neptune, and Pluto, which represent deep psychological changes, spiritual experiences, and personal growth. This system highlights the role of free will and inner awareness in shaping life.

In summary, both traditional and modern forms of astrology-whether from the Vedic or Western system-offer useful insights into relationships. When these approaches are combined, they provide a richer and more complete understanding of marital compatibility. This study uses the Sayana (Western tropical) system to show how ancient rules and modern ideas can work together to explain relationship patterns, helping people improve their personal and emotional lives.

**Objective:** The objective of this case study is to evaluate marital compatibility between two individuals using the Western (Sayana) astrological framework.

The study aims to explore long-term relationship compatibility by analyzing psychological, emotional, and relational dynamics using synastry techniques, focusing on planetary aspects and house placements within the tropical zodiac system.

Materials and Method: This case study examines marital compatibility using the Sayana (Tropical) system of Western astrology, focusing on emotional, psychological, and spiritual alignment. Individual birth charts and synastry were analyzed, with emphasis on the 7th house and related houses (2nd, 5th, 8th, 11th, and 12th), addressing themes like intimacy and shared values. Charts were generated using reliable tropical astrology software and verified through ephemeris. ### **Study Framework and Procedure**

The compatibility analysis began with an in-depth examination of each partner's individual natal chart, focusing on key marital indicators such as the 7th house, its ruler, Venus, and significant aspects-especially those from Saturn, Mars, and Jupiter. Gender-specific indicators were also considered: the male chart emphasized Venus, Moon, and the Progressed Moon's first aspect, revealing emotional tendencies and karmic patterns in love, while the female chart focused on the Sun, Mars, and Progressed Sun aspects to understand her expectations of a partner.

The study then moved to synastry and divisional charts, analysing inter-chart planetary aspects (like Venus-Mars and Sun-Moon), house overlays in key relationship houses (1st, 2nd, 5th, 7th, 8th, 11th), and the Navamsa (D9) for marital depth and harmony. The Saptamsa (D7) was reviewed to assess potential for childbirth and ancestral karmic themes.

Outer planets were symbolically analyzed for deeper karmic, emotional, and health-related transformations. Based on planetary afflictions, spiritual remedies such as mantra chanting, pilgrimage, and gemstone use were recommended to strengthen the relationship.

### **Summary**

This case study, based on the Sayana (Western tropical) system, indicates strong marital compatibility through harmonious Sun, Moon, and Venus trines, supporting emotional connection and shared goals. Saturn adds resilience, while challenges from Mercury-Saturn and Jupiter squares suggest potential delays and ideological differences. Navamsa (D9) and Saptamsa (D7) charts confirm deeper compatibility but reveal karmic influences communication issues. Spiritual remedies and Dasha- based pacification are advised. Overall, this holistic synastry and divisional chart analysis highlights the importance of psychological insight, spiritual alignment, and conscious communication for lasting harmony and mutual growth in the marital relationship.

#### Results

### Natal (D1) Chart

### Moon-Sun Trine (Boy's Moon and Girl's Sun)

Indicates mutual understanding in spiritual, health, social status, emotional, and intellectual matters and Promotes a strong and harmonious relationship. According to Raphael's Manual of Astrology, a trine between luminaries fosters psychological compatibility and mutual encouragement in personal ambitions. The Sun symbolizes will and authority; the Moon governs receptivity and emotions. A trine aspect ensures a balanced functioning of these faculties.

### Saturn-Moon Sextile (Boy's Saturn and Girl's Moon)

Suggests endurance through difficulties, misfortunes, or separations, supported by patience and mutual respect. Sepharial notes that this aspect produces emotional steadiness in domestic life. Indicates long-lasting partnerships based on responsibility and maturity.

### **Venus-Venus Trine (Both Eighth Lords)**

Reflects harmony in married life and mutual contentment and possibility of ancestral property or inheritance. As per Alan Leo, Venus trines in this context promote material comfort in marriage. It also emphasizes shared pleasure and cooperation in domestic investments.

Second House Placements Involving Venus, Uranus, Sun, and Jupiter:

- **Boy's Chart:** Girl's Venus (Vargottama) conjunct Uranus in his second house.
- Girl's Chart: Boy's Jupiter conjunct Sun in her second house.
- It indicates a fortunate family life and timely financial resources. Both individuals display compassion toward family members, are inclined toward fine arts, and leads a joyful domestic life.
- The wife may feel temporarily unrecognized in family settings but will remain determined, albeit somewhat stubborn.
- Uranus may bring financial unpredictability, but Jupiter's conjunction with the Sun ensures resilience and prosperity through wisdom.
- There are no aspects between both second lords but the male second Lord in female's fifth house, and the female second lord in male's 11th house without any aspect. Also male Jupiter conjunction female second house. Signal financial fortune, creative inclination, and familyoriented prosperity.

# Fifth House Lords (for Male and Female is Saturn) in Square Aspect

- Emotional closeness and affection may be limited.
- Possibility of delays and obstacles in achieving hopes and ambitions.
- Alan Leo states that Saturn squares indicate belief system conflicts, affecting romantic spontaneity.
- These tensions can be resolved through conscious alignment in philosophical or religious views.

# Eleventh House Lords (for Male and Female is Sun) in Trine Aspect

The trine aspect signifies strong mutual understanding and collaboration, enabling the couple to achieve shared goals successfully. It reflects generosity, compassion, and support from influential connections, ultimately promoting social growth and alignment in long-term aspirations.

#### Navamsa (D9) Chart

Male's D9 Lagna Lord (Jupiter) in Female's D9 Fifth House

- It indicates strong spiritual and emotional compatibility.
- The exalted Moon in female chart enhances intuitive receptivity and nurturing qualities within the marriage and leads a harmonious and emotionally fulfilling bond from the wife's side.

## Female's D9 Lagna Lord (Mars) in Male's D9 Fifth House posited in own house

- Husband shows moderate compatibility with the wife.
- Sayana commentators caution that the Mercury-Mars influence can lead to cognitive dissonance unless supported by shared intellectual pursuits.

# Male's D9 Seventh House Lord (Mercury) in Twelfth House, Conjoined with Saturn

- Indicates difficulties in managing the wife or in understanding her emotional needs.
- Saturn's cold nature restricts emotional communication.
- May create emotional detachment and barriers in the relationship.
- In Sayana interpretation, this is considered a delaying factor in conjugal intimacy and emotional closeness.

# Female's D9 Seventh House Lord (Venus) in Eighth House (Enemy House):

• Suggests challenges in managing the husband or meeting marital expectations.

- May lead to emotional unpredictability or trust issues.
- These challenges may be mitigated if Venus receives benefic aspects elsewhere in the chart.

# Male's D9 Seventh Lord (Mercury) is placed in Female's D9 Fifth House along with Jupiter

- It is Favorable for the male in marriage and Indicates intellectual and emotional expansion through the relationship.
- Suggests alignment in mutual goals and philosophical or spiritual outlook.

Female's D9 Seventh Lord (Venus) is placed in Male's D9 Lagna: It is Very favorable for the female partner, and Marriage brings emotional and personal fulfillment.It strengthens her identity and self-worth through the marital relationship.

#### 3. Saptamsa (D7) Chart

Female Lagna lord Jupiter placed in male D7 lagna and aspected her lagna by trine. Both Lagnas are having connection with Jupiter and this shows divine grace in childbirth.

### Male's D7: Jupiter and Ketu are posited in Lagna

- Jupiter in the Lagna ensures blessings and fortune regarding children.
- Ketu may cause karmic complications or emotional detachment.
- Children will be born through spiritual merit.
- Ketu's influence may lead to emotional or health-related concerns in the children. male's D7: Mercury and Saturn are Posited in Lagna
- Saturn, Mercury (Enemy House) in the Lagna Indicates an intellectual and thoughtful approach and overthinking regarding children (child-rearing)
- Mercury may bring duality, indecision, or anxiety.

### **Combined Interpretation (Both Charts)**

- Challenges may arise due to the combined effects of Ketu, Jupiter, Saturn and Mercury.
- Minor health disturbances may occur during the children's early years. Male's D7 Seventh House: Venus in Own Sign
- Venus placed in its own sign indicates a favorable and auspicious birth of the second child.
- The second child is likely to enjoy better well-being and potential than the first.

# 4. Current Dasha and Remedial Measures For the Male (Current Dasha: Mars)

Mars is placed in its own house in the Navamsa chart, indicating moderate outcomes during this period. To mitigate its negative effects, Mars Shanti rituals are advised. Visiting sacred temples like Subrahmanya Swamy Temple in Tiruttani or Kukke Subrahmanya Temple in Karnataka is recommended for Mangal Dosha rectification. Regular spiritual practices such as reciting the Hanuman Chalisa and Angaraka Stotra on Tuesdays will aid in balancing Mars's energy. For financial and domestic stability, daily chanting of Sri Suktam and Lakshmi Ashtottara Shatanamavali is beneficial. A diamond or pearl may be worn on the right-hand index finger in silver after proper astrological consultation and purification rituals.

For the Female (Upcoming Dasha: Rahu from May 2025):

Rahu is placed in her Lagna and aspected by the Moon, which may bring emotional instability. Remedial measures include performing Rahu Japam (18,000 times) and offering charity on Saturdays using black sesame, urad dal, and blankets. Visiting Sri Kalahasti Temple during Rahu Kalam on Mondays or Saturdays, especially in Shukla Paksha, is recommended for dosha resolution. Daily chanting of "Om Dum Durgayei Namaha" 108 times and reciting Durga Saptashati on Fridays and during Navaratri will help strengthen inner resilience. Wearing an energized Navaratna ring on the right-hand ring finger under auspicious planetary timing is advised. Mental peace and Rahu control can be supported by daily recitation of the Vishnu Sahasranama.

### Discussion

The Western (Sayana) astrological system focuses on psychological, emotional, and relational dynamics rather than fixed fate. In this case, favorable trines— particularly the aspects—indicate and Sun-Sun understanding, emotional support, and shared aspirations. Venus's placement enhances emotional fulfillment and financial stability through marriage. However, Saturn's involvement adds responsibility but may restrict emotional expression, potentially causing distance if not addressed. Square aspects involving Saturn and Jupiter highlight ideological differences and delays in emotional or family matters, particularly related to children. The Navamsa (D9) and Saptamsa (D7) charts confirm core compatibility while revealing areas that need conscious effort, especially due to Mercury, Ketu, and Saturn influences.

The D9 and D7 emphasize the need for active emotional engagement and spiritual maturity. Ketu in the D7 and the upcoming Rahu Mahadasha for the female may bring karmic challenges and emotional turbulence, requiring spiritual remedies and discipline. The male's current Mars Dasha necessitates focused action and traditional Mars pacification practices to manage intensity and sustain relational harmony.
