# An approach to establish an association between occult sciences and forensics

#### Abstrac

This study explores the intersection of forensic science and Vedic astrology through a unique analysis of astrological indications associated with sudden deaths, based on five postmortem cases. One hundred palm print samples were obtained from deceased people brought to the Department of Forensic Medicine, Institute of Medical Sciences. In addition to palm prints, essential biographical information such as date, time, and location of birth was documented using a standard questionnaire completed by family members. Owing to data incompleteness in multiple cases, only five individuals with complete and verified birth information were chosen for comprehensive astrological analysis.=

Astrological charts were produced utilizing latest version of Parashara's Light 9.0, covering both the D1 (Lagna) and D9 (Navamsha) charts. The research utilized old Vedic literature, writings by K.N. Rao, and perspectives from modern astrologers to ascertain planetary placements and Dasha sequences associated with death-related phenomena. Essential parameters evaluated covered Shadbala strength, the functional features of planets, their positioning in dusthanas refers to (6th, 8th, 12th houses) often called as "house of sufferings", malefic afflictions, and the timing of Mahadasha, Antardasha, and Pratyantar Dasha.

# Introduction

Indian astronomy and astrology developed together. The earliest treatise on Jyotisha, the Bhrigu Samhita, was compiled by the sage of Bhrigu during the Vedic era. The sage Bhrigu is also called the Father of Hindu Astrology, and is one of the venerated Saptarishi or seven Vedic sages. The Saptarishis are also symbolized by the seven main stars in the Ursa major constellation [1]. The documented history of Jyotisha in the subsequent newer sense of modern Horoscopic Astrology is associated with the interaction of Indian and Hellenistic cultures through the Greco-Bactrian and Indo-Greek kingdoms. The oldest astrological treatise in Sanskrit is the Yavanajataka ("Sayings of the Greeks"), composed around the 2nd century CE [1]. It marks the fusion of Hellenistic astrology with Indian traditions and laid the foundation for later classical Indian astrological texts, profoundly influencing the development of Jyotisha (Indian astrology). Jyotisha or Jyotishya (from jyot - "light, heavenly body" and ish - from Ishvara or God) is the traditional Hindu system of astrology, also known as Hindu Astrology, Indian astrology and more recently Vedic astrology. [3,4] Astrology's roots can be traced back to the dawn of civilization, with evidence of its practice dating to around 5000 BCE or earlier. Ancient Roman and Egyptian civilizations demonstrated a sophisticated understanding of astrology, utilizing its principles for societal and environmental development. Despite its long history, astrology faces mounting skepticism from those who prioritize scientific methodologies. Critics argue that astrology lacks scientific merit and should be discontinued as a field of study and practice. They contend that astrological predictions are unreliable and offer no tangible benefits to humanity or nature. These critics question its ability to accurately forecast events or provide insights into an individual's past and future. They argue that resources allocated to astrological studies could be better utilized in other fields. Proponents of astrology, however, maintain that its holistic approach to understanding human experiences and natural phenomena offers unique perspectives not captured by conventional scientific methods. They argue that astrology's enduring popularity across cultures and millennia suggests its continued relevance to human society. The ongoing debate raises important questions about the nature of knowledge, the criteria for scientific validity, and the role of traditional practices in modern society.

As this discussion evolves, it challenges both critics and supporters to critically examine their positions and the debate surrounding astrology's scientific validity has intensified in recent times.

#### **Material and Methods**

For this study, a total of 100 postmortem palm print samples were collected from individuals brought to the Department of Forensic Medicine, Institute of Medical Sciences. The palm prints were obtained using standard ink and roller techniques to ensure clarity and uniformity. Alongside the collection of physical evidence, personal background information was gathered using a specially designed proforma, filled in consultation with the relatives or guardians of the deceased.

The proforma was structured to collect essential details, particularly the date of birth, which is a critical input for astrological analysis. However, due to incomplete or unavailable information from several families, a large number of cases had to be excluded from the final study.

After applying exclusion criteria, only five cases were selected for detailed astrological analysis these were the samples where complete personal details were successfully obtained from the family members.

This combination of traditional palmistry, verified astrological data, and reliable software assisted interpretations forms the basis of the study.



- Lagna Lord (Saturn) is retrograde and placed in the 7th house (Maraka) a key death-inflicting placement.
- Moon in the 8th house with Ketu: Indicates mental sensitivity, emotional trauma, and karmic vulnerability to sudden or mysterious events.
- Mars + Sun + Mercury in 12th house:
- 12th house indicates loss, isolation, hospitalization, or even foreign death.

- Strong fiery influence in house of exit could indicate surgical, traumatic, or mental health-related endings.
- Rahu in 2nd house (Maraka sthana): Malefic presence here activates maraca outcomes during dasha.
- Jupiter in 11<sup>th</sup> although technically benefic, aspects 3rd, 5th, 7th and could support karma fulfilment.
- Ketu in 8th house strong indication of past-life karmic debts or sudden/early death, especially during Rahu-Ketu dasha cycle.



- Ketu in 8th house (Scorpio Exalted): Indicates karmic debt, potential sudden death or accidents; mystic or secretive death causes.

- Rahu in 2nd house (Exalted): Malefic influence in a maraka house; risk of unnatural death or poisoning, eating-related disorders.

# Dasha Influence at Time of Death (2025-2026)

At the time of her death, Priya Gupta was undergoing the Mercury-Ketu-Saturn dasha sequence. This is a critical and sensitive planetary combination involving disconnection from the physical body, karmic burdens, and possible structural or mental breakdown.

- Mercury (Mahadasha): If placed in a maraka house or afflicted by malefics, Mercury can lead to nervous system failure, decision instability, or communication-related distress.
- Ketu (Antardasha): A planet of detachment and karmic isolation, Ketu often causes sudden collapse, invisible internal damage, or loss of will to live—especially when associated with the 8th or 12th house.

According to the actual case history - According to information from the police and the deceased's family, Priya Gupta died from injuries incurred in a road traffic accident. The incident caused significant head injury, which eventually caused the death. Despite medical intervention, the severity of her injuries resulted in her eventual death.

The astrological analysis of Priya Gupta's chart shows significant planetary alignments linked to psychological and neurological vulnerability. The afflicted Moon representing the mind coupled with Rahu in the 4th house, signifies emotional instability and internal turmoil. The alignment of Ketu, Sun, Mars, and Saturn in the 9th house indicates karmic pressure in addition to neurological suppression.

These and other characteristics, along with malefic planetary influence indicate an increased risk of neurological trauma, consistent with fatalities resulting from head injuries. Ketu's impact suggests a profound spiritual detachment, aligned with abrupt and destined exits.



#### Observations made from D1 + D9

- Moon (Lagna lord) + Saturn (8th Lord) + Mars (malefic)
   extreme dosha.
- Represents trauma, bleeding, neurological issues, or sudden death.
- All three planets here show loss of vitality, aggravated karma, and vulnerability to fatal external/internal factors.
- Ketu is Karka of Moksha which Signifies disconnection from physical body, past life karma closure, and spiritual exit. Also, Ketu signifies this will be the last birth of this person. Ketu in 1st house with Moon in 8th is classic for karmic detachment by unnatural death.





According to information obtained from the investigating police authorities, the deceased's family, and the husband (currently in police custody), it was revealed that the husband fatally assaulted his wife by striking her on the back of the head with a rod during a domestic altercation. Following the assault, she was admitted to the hospital in critical condition, where she remained under treatment for two days. Despite medical intervention, she ultimately succumbed to her injuries.

In alignment with this tragic chain of events, the astrological analysis of her charts, offers significant validation of a violent and unnatural death, likely at the hands of a close partner. The 8th house is severely afflicted by four malefic planets - Mars, Ketu, Saturn, and Sun all classic indicators of sudden, violent death, especially homicide.

Mars and Ketu, both associated with weapons and injuries, suggest fatal head trauma. The Sun and Saturn in the 8th contribute to life suppression and prolonged suffering. Venus, representing the spouse, is under subtle malefic influence, indicating marital discord. The active Vimshottari dasha (Jupiter-Moon-Ketu) at the time of death emphasizes sudden, fated events and separation from life.

#### Conclusion

After a thorough investigation of the astrological charts of five reported cases of sudden and unnatural deaths reveals a noticeable association between specific planetary positions malefic influences, dashas combinations, and fatal results. The persistent occurrence of afflicted lagnas, activations of the sixth, eighth, and twelfth houses, alongside malefic planetary conjunctions and transits throughout critical intervals, was frequently evident in the charts.

Notably, in two cases (Sample 49) and (Sample 94), the role of Ketu, the planet associated with detachment and spiritual liberation (moksha), was strongly highlighted. Its placement, along with relevant dasha periods, indicated not just a karmic detachment from the physical realm but also a probable influence toward a destined exit pointing toward deeper occult significations of moksha-karaka Ketu in this death.

The astrological configurations analyzed through the D1 (Lagna) and D9 (Navamsha) charts suggest the potential of Jyotish Shastra, a branch of occult sciences, as an auxiliary analytical instrument in

forensic profiling and comprehending the underlying cosmic influences in cases of sudden death. The association noted in these five instances strengthens the assertion that astrological indicators may yield significant insights into life-threatening occurrences when analyzed with precision and impartiality.

This work advances an interdisciplinary method that merges traditional occult knowledge with contemporary forensic investigation, facilitating further exploration and confirmation of astrological parameters in medico-legal contexts.
